The Nevada SBDC was established in 1985 as the premier resource for small business creation and expansion in Nevada. Through its 12-office statewide network, this economic and community development collaborative is one of a national network of over 1000 centers, funded by the U.S. Small Business Administration and leveraged with community partners and educational institutions, including the University of Nevada, Reno and the University of Nevada, Las Vegas. The Nevada SBDC is a statewide program dedicated to assisting local businesses and entrepreneurs diversify and grow Nevada's economy. Services are offered for no-cost due to the support we receive from many community and economic development partners. The College of Business at the University of Nevada, Reno has proudly hosted the Nevada SBDC network for 38 years. The Nevada SBDC aligns firmly with the University of Nevada, Reno's College of Business's and University of Nevada, Las Vegas Office of Economic Development's vision of global outreach, student entrepreneurship, and the ability to drive economic development in our community. The Nevada SBDC also supports student growth through our internships, allowing students real-world access to the mechanisms of developing a small business.

In July-August 2022, the Nevada SBDC and economic development partners implemented the Nevada Small Business Challenges survey to determine needs of new and existing small business owners across the state.

After the pandemic and during the summer of 2022, small businesses primarily needed help with business planning, developing and expanding their customer base, and adjusting their business models. Sometimes small business owners need a leg up, for example, funding a new technology or a piece of machinery. Startup business owners are challenged to find funding but they also need help in developing their new ideas, understanding licensing and taxes, and determining feasibility.

Keeping a pulse on needs continues to guide the Nevada SBDC strategic plan. Statewide staff do our best to be responsive, from updating skills and adopting new technologies to developing new services that will help businesses increase sales and find more customers. The results of the 2022 Nevada Small Business Challenges survey were used to help develop Nevada's State Small Business Credit Initiative (SSBCI) proposal to increase access to capital for socially and economically disadvantaged and very small businesses (less than 10 employees). Like Nevada entrepreneurs, the Nevada SBDC and our partners also continue to learn and adjust.





# **NxLeveL**

NxLeveL is a 15-topic course designed for entrepreneurs who want to expand an existing business and for those seriously considering starting a new business. Guest speakers are brought in each week to share expertise in a particular area of business operations.

NxLeveL Las Vegas was conducted May-August 2022 with Shaundell Newsome of SUMNU Marketing as the facilitator and in collaboration with Workforce Connections. We had 14 graduates with businesses ranging from beauty salons to therapy services. NxLeveL Carson City was conducted August-October 2022 with Kathy Halbardier, Nevada SBDC Advisor as the facilitator and in collaboration with the Adams Hub in Carson City. We had 25 graduates, with businesses

ranging from restaurants to professional services. This series was offered in a hybrid (in-person and virtual) model. Both NxLeveL programs were sponsored by Bank of Nevada and First Independent Bank.



### Success Story Sonny Boys Tours

Reno, NV

After moving to Reno in 2008, Tina Brodrick was looking for ways to supplement her income after returning to school. She decided to start Sonny Boys Tours, a company specializing in rural tours to educate the public about Nevada's wild horses. Brodrick contacted the Nevada SBDC for assistance

in building a website and guidance in marketing her new business. Brodrick spent time with Nevada SBDC advisor Ben Tedore, who helped her build a public-facing website and taught her how to use social media to broaden her customer base. "The Nevada SBDC was available - it was free - and it was the best resource available to help me with social media and the internet," says Broderick. "[Nevada SBDC] is a tremendous help because they have the expertise."



# Nevada SBDC at UNLV

The Nevada SBDC at UNLV continues to keep its finger on the economic pulse of Southern Nevada by participating in roundtable discussions with local political leaders, expanding into the Historic Westside community, and hosting international guests to support growing industries. In January of 2022, Blackfire hosted Julian Escuita Rodriguez, Mexican Consul, to open up conversations regarding business training and import/export opportunities.

The North Las Vegas Small Business Connector celebrated its one year anniversary and continues to provide valuable assistance to business owners and entrepreneurs in the northern part of the valley. In its first year, the office has served 420 clients by providing no-cost business advisory services and educational opportunities. This center has addressed a need in this community and will continue to provide top-tier business support and resources.



The Nevada SBDC at UNLV has emphasized the importance of providing quality education and training to the business owners and entrepreneurs throughout the state. Over the course of 2022, advisors have started developing several webinars and workshops that aim to launch in 2023. Professional development initiatives that were implemented in the last year include workshops and webinars focused on veteran business owners, launching the Women in Business series, participating in the SBA Emerging Leaders Class as facilitators, and securing a grant from the State of Nevada Board of Contractors to offer workshops in Spanish.

### **Success Story Stargazer Inn**

#### Baker, NV

Liz Woolsey dreamed of purchasing a 10-room hotel property just outside of Great Basin National Park in Baker, NV, a perfect spot to accommodate the more than 160,000 visitors that the park saw annually. Woolsey had the plan and the determination, but just didn't know where to go to turn her dream into reality. That's when Woolsey reached out to the Nevada Small Business Development Center and began working with local SBDC business advisor Caroline McIntosh. McIntosh was able to help secure a sizeable

loan from First National Bank of Ely, enabling Woolsey to acquire the property and open up the Stargazer Inn. Then, when Woolsey began experiencing problems with staffing her new business, McIntosh was again able to assist in hiring competent and responsible staff to fill all available shifts.


With all rooms booked for the duration of the 2022 season, it's clear to see that Woolsey's vision has come to pass - and the Stargazer is open for business!

### **Small Business Challenges Survey**

In 2022, The Nevada SBDC conducted its first Small Business Challenges Survey in Nevada. The survey was designed to take the pulse of small business owners and better understand their current pain points. With nearly 900 small business owners responding, this survey illuminated the concerns and issues facing Silver State business owners and entrepreneurs, and helped guide the SBDC and our partners in strategizing new and improved business services.


"Unfortunately, capital funding continues to be elusive for businesses in Nevada," said Winnie Dowling, Nevada SBDC State Director. "While this is nothing new, it puts startups in the uncomfortable position of paying a lot more to get up and running, especially in our underserved communities. Knowing what businesses need is important to everyone." Of the 225 respondents looking to start a small business or a scalable startup, 58% claimed that securing financing is one of the top three challenges they encountered while attempting to start their business in Nevada. When it comes to developing a business strategy, 54% of those same respondents said that creating a business plan and/or comprehensive marketing strategy posed a significant challenge to the success of their small business.

The survey results also showed that existing businesses have been affected by inflation and rising energy costs. Nearly 50% of the 486 existing business respondents claimed that inflation was a significant challenge, and 47% said that developing a business expansion plan and finding new customers posed an issue. Other challenges included hiring and retaining employees and navigating government regulations.

#### Startup Nevada businesses are most commonly experiencing these challenges:





"GOED's highly successful expansion of the federal State Small Business Credit Initiative (SSBCI) 2022 in Nevada marked a new level in the agency's close collaboration with the Nevada Small Business Development Center. Specifically, the Nevada SBDC will be operating the Technical Assistance portion of the state's SSBCI program. In preparation for GOED's application, the SBDC conducted the Small Business Challenges Survey providing essential data required for the proposed design of the technical assistance program. The degree of results received were a testimony of the power of the SBDC's network and close relationships with Nevada's chambers of commerce, development authorities, and economic development partners."

### **Hispanic Services**

With over 50,000 Hispanic-owned firms in Nevada as of 2019, and a rapidly growing Hispanic population, ensuring that these business owners have access to professional advising and quality information is a primary objective of the Nevada SBDC. In partnership with the U.S. SBA and Wells Fargo, Nevada SBDC provided business advising and training to 1,540 Latinx clients in 2022, with 53 business- starts and 1,655 jobs supported. The Nevada SBC retains 7 Spanish Speaking advisors who are experts in their fields and are well connected within their communities.

### **Success Story**

### North 5th Brewing Co.

#### North Las Vegas, NV

After working at her father's North Las Vegas construction company for years, Amanda Payan found herself in charge of operations when her father retired. Payan and her brother decided to pivot the business and convert their construction headquarters into a cozy, inviting brewery.

Payan quickly realized that the costs of establishing her new brewery were going to be more than she could take on, needing additional capital to purchase brewing equipment and fund the marketing efforts of her new business. Not knowing where to turn, Payan reached out to the Nevada Small Business Development Center and worked with local business advisor Carlos Mejia to secure business loans which allowed her to purchase the

equipment necessary to begin building her dream business. Mejia was also able to offer Payan a social media audit, illuminating the strengths, weaknesses, and gaps in North 5th Brewing's online presence.

Thanks to the help of the Nevada SBDC, Amanda Payan and her family now operate an extremely successful brewery in North Las Vegas, hosting a popular weekly bar trivia night and offering 12 unique brews.

### **SWCREDA**

The Southwest Central Regional Economic Development Authority (SWCREDA) is the state-designated regional development authority for Nye and Esmeralda Counties in Nevada. SWCREDA collects, organizes, reproduces, and disseminates information for the purpose of improving economic and business conditions, and has recently partnered with Nevada SBDC for training and direct-to-business advising in the region.

SWCREDA also works extensively with Nevada Mining (including loneer, Cypress, and Silver Peak mines), the University of Nevada, Reno, and the Governor's Office of Economic Development to improve economic conditions for some of Nevada's smallest rural towns. SWCREDA directly helps small rural businesses, with seven new and six existing businesses receiving a total of \$92,200 in low interest loans to assist with startup costs, new equipment, licensing and permitting fees in 2022.

# Success Story Casas Counter & Granite

#### Henderson, NV

Starting up your dream business from scratch is no easy task, but with help from experienced Nevada SBDC advisors like Anabel Navarro, what might seem scary can be broken into smaller, more manageable projects. That's what Navarro helped Maria Lourdes "Lulu" Casas with when she and her husband decided to open a custom cabinetry business. While her husband had experience with cabinet work, Lulu had never operated or administered a business before and had no idea where to start. Nevada SBDC trainings, classes, and on-on-one advising time with Navarro helped to quickly bring her up to speed.



After attending the Start Smart and Money Smart SBDC training classes and getting help with everything from marketing to insurance, hiring employees, and tax law, Lulu and her husband finally felt confident in their business experience and were ready to expand. Navarro assisted the business in receiving a loan from OPORTUN, and was also able to secure a U.S. SBA Paycheck Protection Program (PPP) loan during the COVID pandemic in 2020.

Maria Casas and her husband now operate 3 separate businesses, specializing in custom closets, garage organizers and stone countertops. They employ more than 15 people and utilize many special contractors in the Las Vegas area. Recently, they opened their first showroom, an exciting milestone that is sure to keep the business booming!
